Camacho Rd., Tamuning, GU 96913 at which time and place all bids will be publicly opened and read aloud. The term for the project is One Hundred Twenty (120) days. All bids must be accompanied by a Bid Bond in the amount of fifteen percent (15%) of the total bid amount. Bid security may be in the form of a bid bond, certified check or cashier's check made payable to Guam Memorial Hospital Authority.

Bids and amendments will be available on GMHA's website for downloading at the following address: www.gmha.org. Vendors are required to routinely check for updates on the website as well as for emails from GMHA notifying vendors about changes in bid status or providing responses to queries. A non-refundable amount of twenty dollars (\$20.00) is required for the purchase price of every set of the bidding documents (hard copies) which are available at Materials Management Office on or after **February 17, 2023**.


