Any questions or requests for clarification arising from the site visit, the Scope of Services, or the bid submission must be submitted in writing as an RFI prior to the stated deadline.

Question: Please confirm that we should plan to respond with our formal bid with the April 7th due date.

Question: We are reaching out to kindly request a 3-week extension on the bid submission and opening currently scheduled on April 07, 2026, at 9:30 AM for IFB 005-2026.

Response: The current bid submission deadline is Tuesday, April 7, 2026, at 9:30 a.m. However, in order to facilitate open competition, an extension has been granted.

The new bid submission deadline is Tuesday, April 28, 2026, at 9:30 a.m. Bids will be publicly opened at 9:45 a.m. the same day. All bids must be submitted sealed and in duplicate (one (1) original and one (1) copy).

Question: Will you be accepting online bids or must all bids be delivered hard copy?

Response: At this time, online bids will not be accepted for this IFB. Please refer to the instructions on the Invitation for Bid page, as well as the Sealed Bid Solicitation Instructions, Submission of Bids, Section 6(a).
