# AMENDMENT #3 GMHA RFP 001-2026 REVENUE CYCLE MANAGEMENT SERVICES

This amendment is in response to the following inquiries.

QUESTION #1. Do you know what the new date for RFP responses will be?

RESPONSE: Bid submission as reads: 4:00 pm, Tuesday, November 25, 2025 has been changed to read as: Bid Submission 4:00 pm, Monday, December 15, 2025.

Question #2: Can we select certain workstreams of the RFP to bid on separately, or do we need to address all workstreams in order to be eligible?

RESPONSE: GMHA is soliciting proposals to outsource RCM in whole or in part (page 2 - Purpose)

Question #3: Rebadging Revenue Cycle Staff - Is this a requirement or preference?
